16/555 Comments from the Public – A member of the public spoke in relation to the noise pollution from events held at Kelmarsh Hall and in particular the Shambala festival. Shambala had applied to Daventry District Council to increase the capacity of the event. The member of the public spoke in relation to his concerns over the impact of this application on the event and in relation to future events held at Kelmarsh Hall.

Another member of the public spoke in support of Shambala festival, for the positive contributions made to the local community and the fact that the event was only held annually. A number of e mails of support had also been received by local residents.
